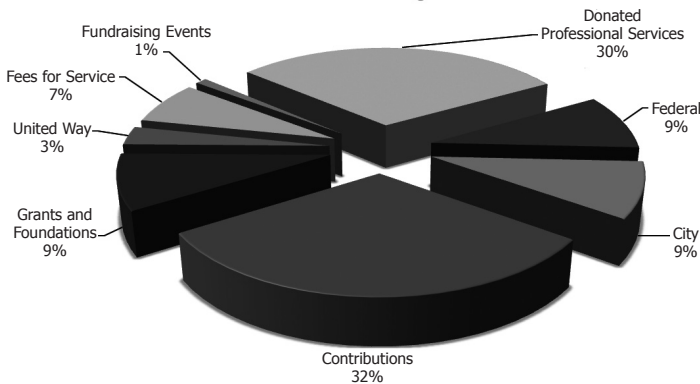

Programs & Services

Medical / Dental Clinics

Beginning with one clinic per week in 1972, Community Outreach has grown to now provide an average of 20 clinics each month in two locations. Community Outreach also provides dental care to low income, uninsured people in dental emergency.

Therapeutic Childcare

Mari's Place, Community Outreach's therapeutic childcare center supports and nurtures children who come from families with a history of domestic violence, drug and alcohol abuse and/or homelessness.

Emergency Services

Community Outreach, Inc. offers Homeless Emergency Services including an Emergency Shelter Program for up to 7 days for homeless men, women, and families. Clients have access to food pantries, phone, mail and message services, information and referral services, and medical clinics for uninsured.

Transitional Housing

Community Outreach's transitional housing program provides a unique opportunity for homeless men, women, and families to learn to become self-sufficient and productive members of our community. In a structured, safe, and supportive environment clients are able to take advantage of our extensive case management services and life skills training.

Case Management

Case Management is a key service offered to all clients in each of our shelters, transitional housing, permanent supportive housing and A & D treatment. Case management is a client-centered, goal-oriented process for assessing clients' needs and helping them obtain the services needed to overcome barriers to housing and employment, and helping clients achieve long-term self-sufficiency.

Permanent Supportive Housing

There is a great need in our county to prevent homelessness and support our community members who have mental illness. Community Outreach's newest program aims to help mental health clients manage the stresses of daily life. Providing services based on individual needs, Community Outreach works to help clients with daily living skills.

Food Provided for Meals

Community Outreach participates in the Oregon Food Bank Network, working to eliminate hunger and its root causes. Operating three in-house food banks to meet clients' needs Community Outreach provides food for those staying in housing, community members and Homeless Emergency Services clients. Community Outreach is the only Benton County food bank that is open weekends, evenings and holidays.

Crisis Intervention

Community Outreach operates the Linn-Benton region's only 24-hour call-in crisis intervention, information, and referral service. This service offers crisis intervention for emotional problems, suicide, domestic violence, drug abuse, runaways, mental illness and information and referral to other community services.

Outpatient Mental Health

Our mental health program provides outpatient treatment services to low-income and homeless men, women and families. Our services include individual and group counseling for adults and families.

Treatment Programs

Our treatment programs include: Alcohol and drug treatment, domestic abuse intervention program, and domestic violence services.

- **Housing for men**
5614 nights of housing for 129 homeless men
- **Housing for families with children**
4503 nights of housing for 37 homeless families, including 2850 nights for 65 children
- **Housing for women**
3383 nights of housing for 63 homeless women
- **Medical Clinics**
2966 visits, 183 general medical clinics held (Corvallis and Lebanon), plus 79 diabetes education clinics, 42 physical therapy clinics, and 18 psychiatric clinics



- **Alcohol and Drug Treatment**
4426 contact hours for 42 individuals, including 40 co-occurring clients (meaning they receive substance abuse and mental health treatment)
